MEMORANDUM OF ASSOCIATION
OF THE
SISTERS OF CHARITY OF NAZARETH

Registration Number 26 of 1962-1963 dated 23 August 1962 -Patna.

	<u>Amended/Altered/Extended</u>
1	Name: The name of the <u>Society</u> is SISTERS OF CHARITY OF NAZARETH (herein after called the "<u>Society</u>"). <u>' Sisters of Charity of Nazareth' is managed by Women Religious Christian Minority.</u>
2	Address: The address of the <u>Society</u> is: <u>SCN Provincial House, KSV Raman Lane, East Boring Canal Road, Patna Dist., Bihar,</u>
3	Objects: <u>Sisters of Charity of Nazareth is a Charitable Society and it endeavours to serve primarily the Christian Minority Community and all, irrespective of caste, creed, sex, or colour.</u> The objects for which the <u>Society</u> is established are the following and it is declared that the several sub-clauses of this clause and all the powers mentioned in it are to be cumulative and in no case is the generality of

the sub-clause nor will any general expression in any sub-clause be narrowed or restricted by any particularity of expression in the same sub-clause or the application of any rule of construction "ejusdem generis" or otherwise:

- a) To perform works of Charity: Social, Corporal, and Spiritual,
- b) To diffuse knowledge: Secular, Moral, Religious and Social,
- c) To establish, Conduct, and maintain, Convents, Academies, Schools, Training Schools for the Members of the Society, Hostels, Orphanages, Homes for the aged, Dispensaries, Hospitals and other allied Institutions,
- f) For the above purposes or in furtherance thereof:-
 - i) To acquire by purchase, lease, gift, grant, legacy, bequest or otherwise from any person, company, or institution whatsoever, movable and/or immovable property of all description and to have the same mutated in any Court or Office (Criminal, Civil, Revenue, Municipal, District, Local, State etc.) to that of the said Society;
 - ii) To maintain, deal with, and manage the said movable and/or immovable properties of all descriptions of the said Society;
 - iii) To alienate by way of sale, mortgage, lease, exchange, gift, hiring out, or otherwise any or all the properties of the Society or portions thereof;
 - iv) To erect Academy and School Buildings, Convents, Hostels, Orphanages, Homes for the Aged, Bungalows, Hospitals, Infirmarys, Dispensaries and any other type of building or construction whatsoever to further the purpose of the said Society, and to maintain, alter, demolish, or reconstruct the same or any portion or portions thereof;

- v) To invest or to deal with the moneys of the Society not immediately required upon such securities or in such manner as from time to time may be determined by the Governing Body of the Society;
- vi) To take or receive any gift, whether moneys or property, movable and/or immovable, such as Real Estate, Stocks, Bonds, etc., whether by gift, or the person living or by legacy, bequest, etc., for any of the objects of the Society, and moreover to take such steps by way of written appeals, public meetings, or otherwise for the securing of such contributions to the funds of the Society as may be deemed expedient;
- vii) To enter into arrangements with any Government or Authority, whether Supreme, State, Provincial, Municipal, local, or otherwise that may deem to be conducive to the objects of the Society or any of them and to obtain from any Government or Authority such rights, concessions and privileges, as the Society may think desirable and to obtain, carry out, exercise, and comply with any such arrangements, rights, privileges, and concessions;
- viii) To borrow and raise funds, with or without security, in any manner the Society may think fit or to repay the same;
- ix) To do or cause to be done all such lawful things as are in accord with the spirit and principles of the Constitution of the Sisters of Charity of Nazareth which are incidental or conducive to the attainment of the above mentioned objects and to the advancement of the Social, Moral, Educational, Cultural, Religious, Civic, Patriotic and physical Welfare of the inhabitants of the Republic of India.
